



Terms and Conditions for 'Singtel Dash – Remittance Cashback Lucky Draw Promotion'

The Singtel Dash – Remittance Cashback Lucky Draw Promotion (the "**Promotion**") is a closed door lucky draw promotion organised by SingCash Pte Ltd ("**Singtel**") and subject to these Terms and Conditions. By participating in the Promotion, all participants shall be deemed to have accepted and agreed to be bound by these Terms and Conditions and all decisions of Singtel, which shall be final and binding in all respects.

1. The Promotion is available from 23 August 2019 and will end on 6 October 2019 (both dates inclusive) (the "**Promotion Period**").

Eligibility

2. To be eligible for the Promotion, the participant must:
 - a) hold a valid Singtel Remittance Account and Dash Balance Account, which said accounts must be and remain valid and must not for any reason be terminated and/or suspended, during the Promotion Period, and
 - b) comply at all times (including, but not limited to, in making the Eligible Transaction) with the terms and conditions governing the use of Singtel Remittance Service and Dash Balance, including, but not limited to, the Dash Terms and Conditions and Remittance Terms and Conditions (both of which may be accessed at <https://www.dash.com.sg/terms-and-conditions/>).
3. Employees of the Singtel Group of Companies and its appointed advertising, media and auditing agencies and any other parties who are directly involved in the organizing, promoting or conducting of the Lucky Draw shall not be eligible to participate in the Promotion.
4. For the avoidance of doubt, participation in the Promotion is open to individuals only. Corporate or other entities shall not be eligible to participate in the Promotion.
5. Singtel reserves the right to request for the participant's proof of identity for the purposes of verifying that the Dash Account from which the Eligible Transactions have been made is registered to the participant. In the absence of such verification as requested, Singtel shall be entitled in its discretion to disqualify the participant from the Promotion, and the participant shall have no claim whatsoever against Singtel in such event.

Conduct of the Draw

6. Six (6) rounds of lucky draw (the "**Lucky Draw**") will be conducted by Singtel at 31B Exeter Road, Comcentre II, #04-00, Singapore 239733 on the following dates or on such other date, time and venue as may be determined at the sole and absolute discretion of Singtel.

- Each participant shall be entitled to one (1) Lucky Draw chance for each S\$100 successfully remitted by the participant to either the Philippines, Indonesia, India, Myanmar or China during the respective Relevant Periods in the table above. Remittance transactions to Bangladesh are excluded from the eligibility for the Promotion.
- There will be ten (10) winners drawn from the Lucky Draw each Week (the “**Weekly Winners**”) for a total of six (6) Weeks to win SGD\$50 in Dash Credit each (the “**Weekly Prize**”). In addition, there will be another three (3) winners (the “**Grand Prize Winners**”) drawn from the Lucky Draw to win SGD\$500 in Dash Credit each (the “**Grand Prize**”). Each participant is eligible to win only once, either the Weekly Prize or the Grand Prize, in the Promotion during the Promotion Period.
- The Winners will be selected at random through a computerised system in the presence of an authorised personnel of Singtel. - Singtel further reserves the right, at its absolute discretion, to change or substitute the Prize and/or to increase or reduce the number of Winners for the Lucky Draw.
- The Winners for the Lucky Draw will be notified via SMS to their Singtel Dash registered telephone number within three (3) working days after the Lucky Draw.
- The Winners will have to collect their Prize in person or by a duly authorised representative at our Singtel Dash Mobile Remittance shops at Lucky Plaza #01-11 or City Plaza #01-02/17, within thirty (30) working days after notification (the “**Collection Period**”). The Winners shall comply with Singtel’s instructions for the purposes of the Lucky Draw. Singtel reserves the right to request for the Winners’ proof of eligibility, identity and/or otherwise for the purposes of verifying the Winners’ claim to the Prize at the time of Prize collection. The Winners must present his/her NRIC or such other identification papers as may be acceptable to Singtel. Where the Prize will be collected by a duly authorised representative of the Winners, the representative must present his/her NRIC or such other identification papers as may be acceptable to Singtel, a copy of the Winners’ NRIC or such other identification papers as may be acceptable to Singtel and the letter of authorisation duly signed by the Winners in such form as may be acceptable to Singtel.



13. Any Prize which is not claimed in accordance with the provisions of these Terms and Conditions within the Collection Period will be forfeited at the sole and absolute discretion of Singtel, and the Winner shall not be entitled to any compensation for the same.
14. All Prizes won or accepted shall be given on an “as-is” basis and are non-transferable, non-assignable, non-exchangeable and non-redeemable for cash and/or any other items. No payment or compensation whether in cash, credit or kind shall be made for any uncollected, lost, misplaced, defaced, stolen or damaged Prizes.

Singtel makes no warranty or representation as to the quality, value, merchantability or fitness for purpose of the Prize and assumes no liability or responsibility for the acts or omissions of the merchants and/or suppliers of the Prize or any non-performance or defects in the Prize. Any dispute about the value, condition or performance of the Prize is to be resolved directly with the relevant merchants and/or suppliers of the Prize.

Singtel reserves the right to disqualify any Winner from the Luck Draw if the Winner is determined, in Singtel’s sole discretion, to be ineligible for any reason whatsoever, at any time, Singtel, at its sole and absolute discretion, suspects any fraud in relation to, and/or misuse of, the Winner’s Dash Balance Account, Singtel Remittance Account and/or the Eligible Transactions; or the phone number which is registered in respect of the Winner’s Dash Balance Account and/or Singtel Remittance Account is for any reason changed (whether by the Winner or any other person, with or without the consent or knowledge of the Winner) during the Relevant Period or at any time before the collection of the Prize by the Winner in accordance with these Terms and Conditions.
17. Singtel shall be entitled, at Singtel’s sole and absolute discretion and without notice to you, to claw-back from you any Lucky Draw Prize which has, in Singtel’s sole opinion, been wrongfully awarded to you for any reason whatsoever, including by reason of any failed remittance.

By accepting the Prize, the Winner agrees that Singtel may use the Winner’s name, addresses, personal details, photographs or any likeness for advertising and promotional purposes without further consideration. However, Singtel is under no obligation whatsoever to disclose the identity of the Winner or to publish the same for any reason at any point of time.

General

Singtel reserves the right to, at its sole and absolute discretion, vary, modify and amend any of these Terms and Conditions and/or to suspend, discontinue or terminate the Promotion/Lucky Draw at any time without prior notification, or liability to any party. These obligations will continue to survive the expiry or termination of the Promotion and/or the Lucky Draw.

26. These Terms and Conditions shall be subject to and construed in accordance with the laws of Singapore and the participants hereby submit to the exclusive jurisdiction of the courts of the Republic of Singapore.
27. A person who is not a party to these Terms and Conditions has no right under the Contracts (Rights of Third Parties) Act of Singapore to enforce or enjoy the benefit of any provision of these Terms and Conditions.
